**Subject: DENSE FOGGY CONDITIONS WILL CONTINUE IN PUNJAB, PLAINS OF KHYBER PAKHTUNKHWA AND UPPER SINDH IN COMING DAYS.**

The undersigned is directed to refer to the subjected cited above and to say that PMD/NDMA has informed that due to stable atmosphere, prevailing dense foggy conditions will continue over Punjab including Islamabad, Khyber Pakhtunkhwa and upper Sindh. A rain bearing westerly weather system is likely to enter in Balochistan on 04<sup>th</sup> January 2024 and may grip areas of Balochistan till 05<sup>th</sup> January 2024.

Under the influence of this weather system:

- Light to moderate Rain/wind-thunderstorm (with snowfall over the hills) is also expected in Loralai, Killa Abdullah, Chaman, Killa Saifullah, Quetta, Pishin, Ziarat, Mastung, Zhob, Kalat, Musa Khail, Kharan, Harnai, Sibi, Nushki, Chagla, Khuzdar, Surab and Makran coastal areas on 04<sup>th</sup> January 2024 to 05<sup>th</sup> January 2024.

Impacts and Advises

- Very cold weather conditions are likely to prevail in fog affected areas.
- Farmers are advised to manage their crop activities accordingly.
- Tourists and travelers are advised to remain extra cautious to avoid any untoward situation during the weather forecast period.
- Exposure to foggy environment may cause health issues.
- Flights, Railways and Highways / Motorways operations may be disrupted.
- General public is advised to stay at safe places during rain-wind / lightning.

**Note:** All concerned authorities are advised to remain "**ALERT**" and take necessary precautionary measure during the forecast period.
